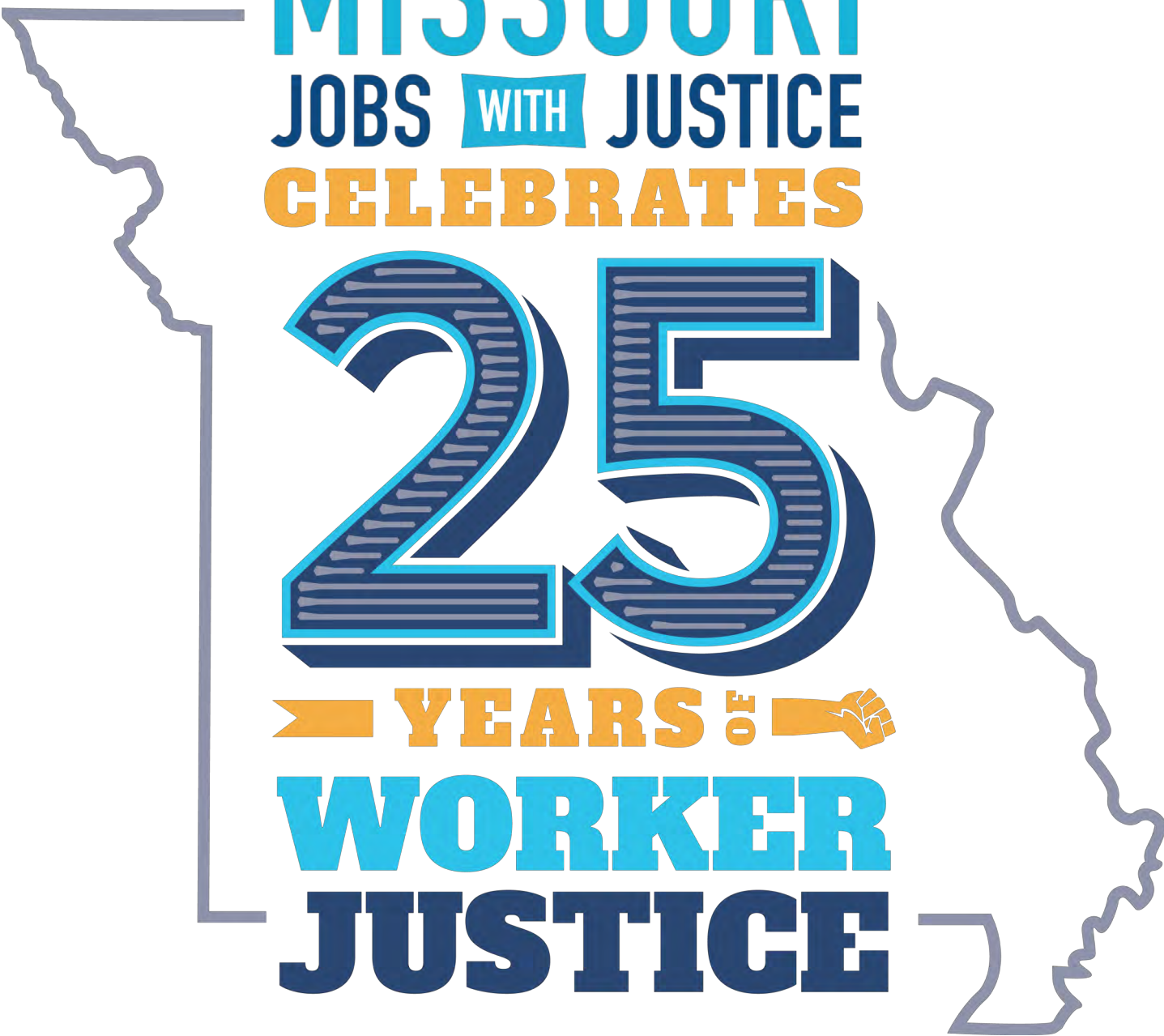

Solidarity: A Letter from our Executive Director

As we approach the latter part of the year, I want to take a moment to reflect on the hard work we've done and the milestones we've achieved together. At MOJwJ, we are celebrating our 25th anniversary-- a history that has taken us from a small St. Louis organization to one of the largest, most powerful grassroots organizations in the state. I've spent time this past year revisiting our history, remembering the workers and leaders that built this organization, and all that we have won together in 25 years. It really is incredible.

This year is no different. In 2024, workers have faced challenges head-on and together, we've celebrated numerous successes. Whether it was adapting to new ways of organizing, launching a statewide ballot campaign, or simply supporting each other in workplace fights and a hostile legislature, our collective resilience and dedication has been truly inspiring.

You have been a part of engaging in conversations with over 200,000 Missourians. You were part of a statewide team of MOJwJ activists that gathered over 125,000 signatures on Health Families and Fair Wages and Missourians for Constitutional Freedom. These policies will increase wages, expand access to paid sick leave, and overturn the cruel abortion ban in Missouri. With your ongoing support, we plan to pass these policy campaigns in November!

As we continue our work, we take your unwavering efforts seriously. Together, we can create a Missouri where we are valued and respected, and our rights are expanded, not chipped away.

While it may be difficult to remain hopeful in a place like Missouri, countless opportunities lie ahead to refocus the conversation on workers and create an economy that benefits everyone, not just a select few. I am choosing to believe the majority of Missourians are good and redeemable if we only take the time to knock on their door, meet them at their church, join them at their picket line, or show up at their community meeting and engage in relational conversations. Together, we can organize folks toward a vision of the future—and their own interests—centered on multiracial solidarity and collective well-being.

Thanks for 25 years of building a Missouri that works for all of us.
